Membership.

As at February 1st 1982, the total membership of the Section was 199 - a promising start indeed! Sectional Groups.

At present four Sectional Groups have been approved by General Council, (N.S.W., Victoria, W.A., S.A.). This will be passed on to General Council for approval.

New South Wales Group.

The N.S.W. Group will have its inaugural meeting on Wednesday, February 24th, at the Biomedical Library, University of NSW at 6 p.m. Office bearers will be elected then. The Group plans to hold a day-seminar on cataloguing in August, possibly combined with a seminar on the minor MEDLARS data bases RTECS, TDB etc.

Branch Council.

Each sectional group should get in touch with its State Branch Council. Under the N.S.W. Branch Constitution all Sectional Groups are required to be represented on Branch Council. This may not be the case in other States.

Section Meetings.

Two Section Meetings were held in 1981. On August 31st, Allan Horton, University Librarian, University of N.S.W., spoke on aspects of the Copyright Law and the 1980 Copyright Amendment Act. Over 70 people attended the meeting at the Commonwealth Institute of Health. The discussion was lively and the meeting ended at 9 p.m.

On November 24th in the Bosch Building, University of Sydney, Professor Carmel Maguire of the School of Librarianship, University of N.S.W. discussed her feasibility study on the projected Manual of Hospital Librarianship being undertaken with the support of the National Library. Carmel and Eugenia Lovelace have recently conducted interviews with medical librarians around Australia and the results of their survey will be available by the end of February.

Committee Meetings.

Four Committee Meetings have been held. Some of the issues discussed have an important bearing on future developments of the Section and the Committee would welcome comments and suggestions from members.

LAA Biennial Conference (22nd) Adelaide, August, 1982.

The Section would not offer a formal programme. Library visits and possibly an informal social function may be organised by S.A. members (details in Newsletter 2).

Rotation of National Committee.

At a Committee Meeting on January 19th, it was decided that we should follow the model of the Special Libraries Section whereby each State hosts the National Committee for a two-year period. This should coincide with the holding of our Biennial Conference and the National Committee would organise the Conference in its own State during its period of office. The W.A. Group has offered to hold the Medical Librarians' Conference in Perth in August or September 1983 - this would coincide with the Specials' Conference planned for Perth in 1983. The Committee recommended that W.A. be the host State for the National Committee for 1983/84 and that the venue of the next

conference and the location of the National Committee for 1985/86 be decided at the Perth Conference.


Newsletter.
