

Members of the Group met during the 1975 Library Association Conference at a symposium organised by the Victorian Branch. It was decided that a National Newsletter for the Group should be produced.

### Formation of the Australian Medical Librarians' Group

It may be of interest to record the background to the formation of the Group. In May 1971 Ann Harrison, Librarian, Brownless Medical Library, University of Melbourne, wrote to a number of university medical librarians suggesting that they meet at the LAA Conference which was held in Sydney in that year. The meeting took place at the Medical Branch Library, University of Sydney on 27 August 1971. Present were: Brenda Heagney, Medical Branch Library, University of Sydney; Ann Harrison; Jac Baillie, Biomedical Library, Monash University; Judith Lloyd, Medical Library, University of Adelaide; and George Franki. It was decided that meetings should be called in state capitals with the purpose of forming state branches of an Australian Medical Librarians' Group. The aims of the Group were to be:

1. The advancement of the needs of medical librarians in Australia.
2. The development of better liaison between medical librarians in Australia.
3. The development of education programmes for medical librarians.

Since 1971 branches of the Group have been operating successfully in New South Wales, Victoria and the A.C.T. It is understood that branches may be developed soon in Queensland, Western Australia and South Australia.

Regular meetings of the state branches of the Group have been held. The New South Wales Branch conducted a seminar in 1973 and the Victoria Branch a symposium at the LAA Conference in 1975. The Group has made submissions to appropriate bodies concerning ALBIS, STIEC, and to the KARMEI Committee on medical education.

Perhaps the area in which the Groups have made the earliest impact is in increased liaison between medical librarians in capital cities and nationally. If for no other reason, the Groups have been successful.

### National Council
